**A RESOLUTION APPROVING PARTICIPATION WITH THE STATE OF NEW  
JERSEY IN A SAFE AND SECURE COMMUNITIES PROGRAM ADMINISTERED  
BY THE DIVISION OF CRIMINAL JUSTICE, DEPARTMENT OF LAW AND  
PUBLIC SAFETY**

**WHEREAS**, the Delran Township Council wishes to apply for funding of approximately \$60,000 with a match of \$154,619 for an approximate project total cost of \$214,435 for a project under the State of New Jersey Safe and Secure Communities Grant Program and

**WHEREAS**, the Township Council has reviewed the accompanying application and has approved said request, and

**WHEREAS**, the project is a joint effort between the Department of Law and Public Safety and the Township Council of the Township of Delran for the purpose described in the application:

**THEREFORE, BE IT RESOLVED** by the Township Council that

1) As a matter of public policy, the Township Council of the Township of Delran wishes to participate to fullest extent possible with the Department of Law and Public Safety.

2) The Attorney General will receive funds on behalf of the applicant.

3) The Division of Criminal Justice shall be responsible for the receipt and review of applications for said funds.

4) The Division of Criminal Justice shall initiate allocations to each applicant as authorized.

Mr. Schwartz made a motion, seconded by Mr. O'Connell to approve the Resolution 2015-28.
