**RESOLUTION TO INTRODUCE THE CY 2012 MUNICIPAL BUDGET**

**WHEREAS,** the following statements of revenues and appropriations shall constitute the Municipal Budget for the year 2012; and

**WHEREAS,** said budget be published in the Burlington County Times in the issue of April 10, 2012; and

**WHEREAS,** a public hearing on the budget and tax resolution will be held at the Municipal Building on April 24, 2012 at 7:00 P.M., at which time and place objections to said budget and tax resolution for the CY 2012 Municipal Budget may be presented.

**NOW, THEREFORE, BE IT RESOLVED,** that the Governing Body of the Township of Delran does here by approve the introduction of the 2012 Municipal Budget.

Ms. Pomeranz asked if Council would agree to purchase bottled water for Administration.

Mr. Hatcher stated that the total cost is approximately \$800 per year and this will not affect the budget. Council agreed to provide bottled water for the Administration.

Mr. Morrow made a motion, seconded by Ms. Pomeranz to adopt Resolution 2012-32.

There being no questions, the roll was called.

Mrs. Kolodi, Mr. Schwartz, Ms. Pomeranz, Mr. Morrow and Mr. Catrambone voted aye.

Motion Approved

Mr. Hatcher read the following statement.

The 2012 Municipal Budget provides for a drop in spending from the previous year with total appropriations being reduced by \$54,000 and a drop in taxes with a reduction in the amount to be raised by taxation of \$204,500. The average assessed home will realize a reduction of \$40.44. The budget as presented is \$477,334 under the levy cap implemented two years ago. The total 2012 budget is \$15,631,000 and the amount to be raised by taxation is \$10,500,000.

At this time, Council proceeded with the regularly scheduled work session.
