WORK SESSION MUNICIPAL BUILDING

ROLL CALL: Mrs. Apeadu, Mr. Smith, Mr. Jeney, Mr. Lyon and Mr. Burrell were present.

ALSO PRESENT: Mr. Catrambone, Mayor, Ms. Rizzuto, Solicitor, Mr. D'Armiento, Mr. Bellina, Administrator, and Ms. Eggers, Township Clerk

OATH OF OFFICE

Mr. Catrambone administered the oath of office to Captain Matthew Gasper.

Best Practices Inventory – Mr. Bellina explained that the Best Practices Inventory assesses a municipality's compliance with various rules and regulations. Mr. Bellina reported that we are in excess of what was required and we will be receiving all of our state aid. Mr. Bellina stated that in the future, he anticipates them focusing on a way for residents to charge their electric vehicles.

Mr. Catrambone commented that a company has reached out to the township for recommendations on five locations where they could place charging stations. The company would provide the units and then the property owners would be responsible for the installation. Mr. Catrambone asked anyone with input regarding potential locations, to contact him or Joe Bellina. Mr. Burrell suggested consulting the Green Team for suggestions. Mr. Smith suggested reaching out to our local utility company to see if there are any incentives or rebates available. Mr. Bellina will bring that up at a meeting he is having with the utility company next week.

<u>Delran Community Park – Overhead Net Removal</u> – Mr. Bellina reported that we are still getting costs together for taking the net down for the winter as opposed to keeping it up and risking damage from bad weather. After a brief discussion, it was determined that keeping it up would be the best course of action if the insurance company will cover any damage since the cost for taking it down is over \$10,000.

Haines Mill Road Project – Mr. D'Armiento stated that the work, which will extend from Route 130 to Conrow Road, is currently out to bid. It is the intention to award the job next Tuesday. This project will be partially funded through DOT municipal aid and partially funded by Delran Township. The township has budgeted \$600,000 for this project which will be completed in 2023.

<u>South Jersey Health Insurance Fund</u> – Mr. Bellina reported that the rates for the NJ State Health Insurance Fund are climbing 20% across the entire state. If we move into the South Jersey

Insurance Fund, the increase will be 10% and it will be equal to or better than, what we currently have. After a couple of years, we may have dividend options available as well. Another plus is, there will be a customer advocacy team to help handle any problems members may have.

Mrs. Apeadu asked if this was due to an increase in the employee's health coverage. Mr. Bellina noted that it was. Mr. Catrambone explained that numbers are still being crunched but it does look like it will be a considerable savings for coverage that is as good or better for the employees. If we decide next month to go with South Jersey Insurance Fund, the new coverage would start on February 1st.
