CHANGES TO MS4 STORM DRAINANGE REQUIREMENTS

Township engineer, Ed D'Armiento, reported that there are changes that need to be made within the township by January 1, 2026 to be compliant with new state regulations. Some of these changes include more frequent street sweeping and MS4 infrastructure mapping. All inlet structures within the municipality must be located and placed on a GIS map that is reviewed annually and posted on the township website. Updates need to be made as improvements are completed. Training videos must also be viewed by the governing body, associated boards and township employees.

Mr. Kalac – No report

Mr. D'Armiento – Mr. D'Armiento explained that workers broke ground at the Brown Street Field last week. Fence post installation will commence in the next couple of weeks.

Mr. D'Armiento stated that the contractor for the 2023 Roadway Program anticipates that milling and paving will tentatively, begin around the third week of October.

Mrs. Apeadu – No report

Mr. Smith – Mr. Smith thanked the Delran Historical Society for the years of effort that went into the new lobby exhibit. He also offered prayers to the Schwartz family for their loss.

Mr. Smith cautioned residents about driving now that it is getting darker earlier and wet leaves may make stopping more difficult.

Mr. Jeney – Mr. Jeney offered condolences to the Schwartz family. He mentioned that the Delran Police Department is participating in the Straight to Treatment program. Anyone that feels like they need help with drugs or alcohol can come to the police department on Fridays where treatment will be arranged immediately.

Mr. Jeney congratulated the historical society. He noted that their members are very active in the township and do a lot for people in the community. He invited everyone to come and see the wonderful display in the municipal building.

PUBLIC COMMENT

Ms. Eggers stated that there were no findings this year and the audit will be posted on the township website tomorrow.

Ms. Reppert asked for a definition of a Class 5 Cannabis License. Mr. Burrell and Mr. Bellina explained that it is a retail license. There are four approved for Delran. Ms. Reppert asked if there are tax benefits. Mr. Burrell stated that the intention is for it to be a large tax revenue. Ms. Reppert is concerned that the quality of the township may slip due to the cannabis stores.

Lynda Lyons, 115 Natalie Road – Ms. Lyons asked who monitors affordable housing units, specifically 123 Natalie Road which is now unoccupied. There have been prior issues with water leaking down from that unit which damaged the two units underneath. Ms. Lyons is concerned that the issues have not been repaired and will continue with any new occupants. Mr. Bellina informed her that an inspection will be done. He will keep Ms. Lyons informed of any developments.

Mrs. Apeadu made a motion, seconded by Mr. Smith to close the meeting to the public All were in favor; the motion was approved.

Mr. Lyon made a motion to adjourn the meeting, seconded by Mrs. Apeadu. All were in favor; the meeting was adjourned.
